I am writing to express strong support for the **Madisonville West Side Lift Station Expansion and Upgrade Project**. This project is part of a five-phase plan to resolve recurring sanitary sewer overflows and expand sewer capacity for future growth in Madisonville and surrounding communities.

The five-phase plan referenced above, entitled the West Noel Interceptor Project, includes a new clarifier at the treatment plant, an expansion of the West Side Lift Station, and new gravity sewer mains that will intercept flows that currently flow to the overwhelmed East Side Lift Station. Currently, the clarifier and two of the four phases of the gravity sewer have been funded by the City and are currently under construction. The West Side Lift Station will handle 100% of the flows from this project. The project will increase the capacity from 11MGD to 19.4 MGD. Improvements to the West Side Lift Station must be made to realize the benefits of the four other projects.

This project is critical to Madisonville due to industrial and other growth on the west side of the City and in the City of Hanson. Without this project, the City of Madisonville will not be able to continue to provide adequate wastewater service to the businesses and citizens in the area.
